That the school shall appoint ful time qualified and eligible staff for all the classes of the school as per the present form of the department and shall dispense with the services of unqualified and overaged staff, if any, immidiately. Proof to this effect should be provided to the E.O.for verification.
- That the school shall equip the science lab. as per the norms of the Department and suitable facilities for prectical work shall be provided to the students. More meterial worth Rs. 5,000/- shall be purchased during 1991-92 and a list be furnished to the Education Officer for verification.

- That the school shall not realise any dues other than 9. rates or fee_ mentioned in the application form for recognition and shall obtain permission of Deptt. of Education for any change in rates of fees.
- That the school shall not run any pre primary and unreco-10. gnised classes as or any other activities with in the school premises and all the recognised classes shall be run at one place. Nursary classes be removed from the premises of the school, if any. No branch of this school shall be run under the banner of the recognised school.
- That the service contract between the management and the 11. employees shall be executed immediately.
- That the arrangement of good drinking water shall be made 12. available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately.
- That the violation of any instructions/orders/conditions/ 13. rules and regulations of the department shall leed to the withdrawal of recognition of the school and class IX shall not be opened without the prior approval of the Director of Education Delhi.
- That the Management of the school shall provide all the facilities as per rule 51 and all conditions as required 14. under rule 50 shall be complied with. Provisions of Rules 6,7 & 9 be strictly observed.
